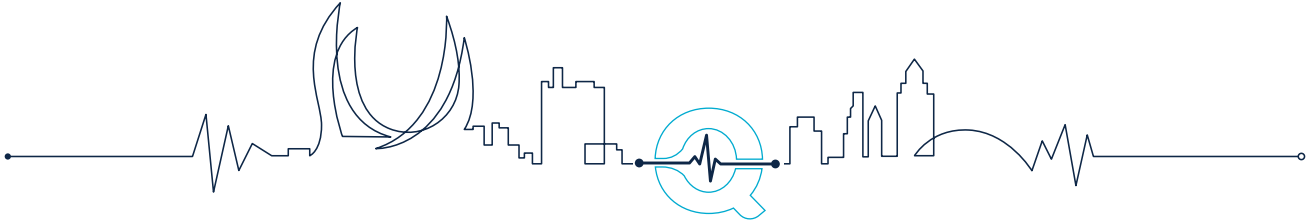

Qatar's Healthcare Market

A Growing Pulse for Expenditure & Business Opportunities



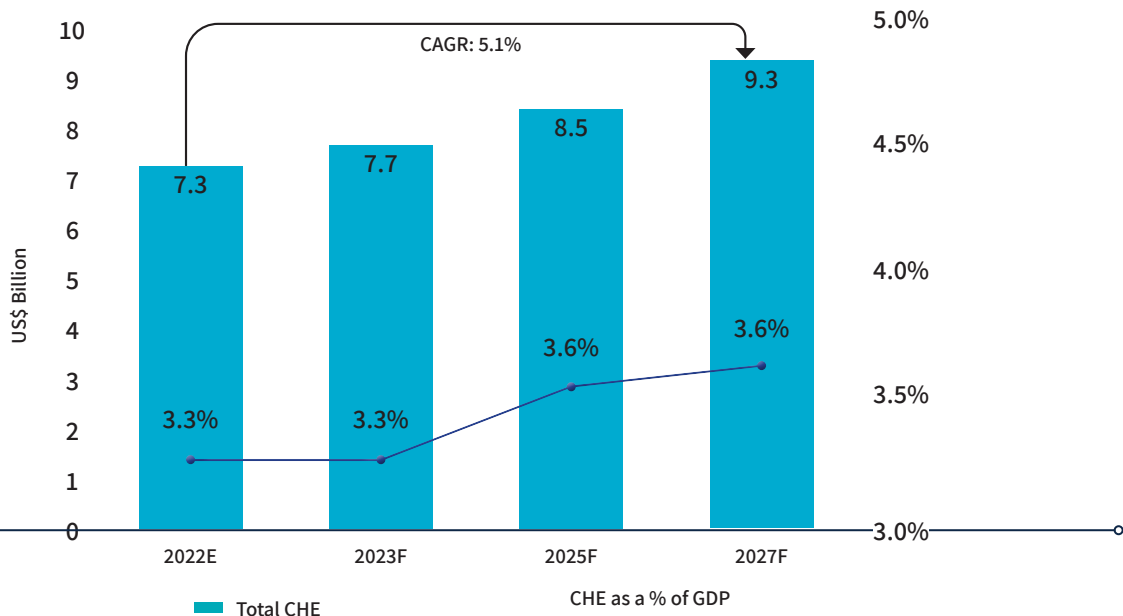
Qatar is set to become an exceedingly attractive healthcare investment destination in the long term as the government continues to increase funding for healthcare infrastructure development and medical equipment and services.

In line with the Ministry of Public Health's long-term target of reaching 5,700 hospital beds by 2033, Qatar's government has been investing heavily in developing an integrated healthcare system that offers high-quality services. Consequently, the healthcare industry has become one of the fastest-growing markets in the world, projected to reach US\$12 billion by the end of 2024. Sustaining this pace, Qatar's healthcare market is likely to outperform its GCC neighbors within the next few years. Qatar boasts the highest healthcare expenditure

per capita in the Gulf Cooperation Council (GCC) with more than US\$ 2,214 per person. Furthermore, healthcare spending in the nation is expected to record a CAGR of 5.1% over the coming five years to reach US\$ 9.3 billion by 2027. This can be largely attributed to the expected population growth, and the introduction of mandatory health insurance for non-Qatari employees and their family members.

Healthcare Facilities Master Plan

Under The National Healthcare Facilities Master Plan, the country's first guide for managing the growth of healthcare infrastructure, aims to deliver 48 new facilities that range from primary health care centers, diagnostic and treatment centers, pharmacies, hospital expansions and the building of both general and specialized hospitals, and the acquisition of cutting-edge technology and major medical equipment.

Hamad Medical Cooperation has unveiled a new 15-year master plan that includes doubling the number of hospital beds and operating theaters in the country and tripling car parking provisions by 2030.

Medical Equipment and Devices

The Qatari government is constantly trying to upgrade the quality of its health services by using advanced technology and international expertise. Revenue in the Medical Devices market in Qatar is projected to reach US\$700 million in 2025. The market is expected to show an annual growth rate (CAGR 2024-2028) of 5.43%, hitting a market volume of US\$1 billion by 2028. The market relies on imports led by the US, followed by Europe and Asia due to the current lack of local production capacity in the area.

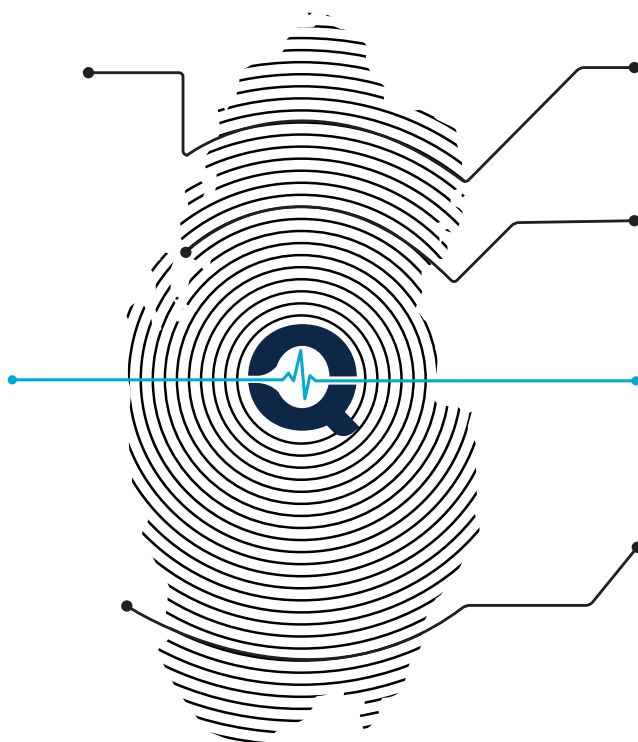
